Technologies® System performance in predictive modeling and business intelligence scenarios on Microsoft Windows Vista

Executive summary

Principled

Intel Corporation (Intel) commissioned Principled Technologies (PT) to compare the performance on Microsoft Windows Vista of an Intel vPro technology based PC with that of three other platforms on common predictive modeling and business intelligence scenarios. We tested two scenarios that involve Microsoft Office Excel 2007 and a third that uses Intuit QuickBooks Pro 2006. We compared the performance of the following four platforms on these scenarios:

- Intel Core 2 Duo processor E6700 on an Intel vPro 965 (DQ965GF) motherboard
- Intel Pentium D processor 930 on an Intel D945GTP motherboard
- Intel Pentium 4 processor 630 on an Intel D945GTP motherboard
- Intel Pentium 4 processor 2.8 GHz on an Intel D865GBF motherboard

As Figure 1 shows, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 significantly

KEY FINDINGS

- The Intel[®] vProTM technology based PC featuring the Intel[®] CoreTM 2 Duo processor E6700 yielded significant performance advantages for users on our sample predictive modeling and business intelligence tests.
- The Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 finished our three test tasks on average 2.53 times faster than the Intel[®] Pentium[®] D processor 930 based PC.
- The Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 also finished our tasks on average 3.34 times faster than the Intel[®] Pentium[®] 4 processor 2.8GHz based PC.
- These performance improvements translate into multi-second time savings that would be noticeable to users.

outperformed the other PCs in all three scenarios. The Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 was from 1.91 times to 3.12 times faster on different tasks than the Intel Pentium D processor 930 based PC and averaged 2.53 times faster across all the tasks. (In all comparisons in which we cite the



average of task times, we use the geometric mean of the normalized times for each task.)

The Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 was from 2.47 to 4.68 times faster on our tests and averaged 3.34 times faster than the PC with the Intel Pentium 4 processor 2.8GHz on the Intel D865GBF motherboard.

These performance improvements translated into multisecond time savings noticeable to users.

For example, the longest task took 77.34 seconds on the Intel Pentium D processor 930 based PC but only 28.55 seconds--almost 49 seconds faster--on the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700.

So that we could make the test systems as similar as reasonably possible while varying the processors and motherboards, we built the systems rather than purchasing them from vendors. Intel specified the general system types. We purchased the processors and motherboards as well as such common components as RAM, hard disks, and optical drives. Each test system had the following basic components (see Appendix A for detailed configuration information):

- 1GB of the fastest RAM its motherboard supported
- 80GB hard disk with an 8MB buffer (SATA unless the motherboard did not support it)
- DVD-RW optical drive
- Microsoft Windows Vista Ultimate

We used the following common business intelligence based applications, which we list in alphabetical order:

- Intuit QuickBooks Pro 2006
- Microsoft Office Excel 2007

The application scenarios we tested included such common functions as:

- Opening files
- Recalculating Excel spreadsheets

In the following sections we look more closely at our test application scenarios (Application scenarios), examine the results of our tests (Test results and analysis), and give detailed information about how we actually performed the tests (Test methodology). In the appendices, we present the configurations of the test systems and explain how to manually execute the application functions in our scenarios.

Application scenarios

We chose scenarios that involve common predictive modeling and business intelligence tasks and applications. In two of our scenarios we used Microsoft Office Excel 2007. The multithreaded design of this new version of Excel paid dividends in user performance on the Intel vPro technology based system. The third scenario uses Intuit QuickBooks Pro 2006, an application common in small and medium businesses.

Recalculating business revenue using Microsoft Office Excel 2007

Brian Corcoran is a forensic accountant investigating a failed business that is the plaintiff in a shareholder classaction suit. He is examining the original spreadsheet the business used to estimate revenues over five years of its telecommunications services. The spreadsheet calculates revenues based on the number of T1 trunks and customers and the penetration of voice, call management, and multimedia services. Brian recalculates the Excel spreadsheet to see how the various models it employs compare to the actual revenues of the company.

We timed:

• the Microsoft Excel 2007 calculation from when Brian presses F9 in Excel to start the recalculation until the recalculation percentage indicator reached 100 percent and closed

Running a Monte Carlo simulation in Microsoft Office Excel 2007

Jordan Michaels, a GMC auto dealer, believes that demand for new Envoys will be normally distributed with a mean of 200 and standard deviation of 30. His cost of receiving an Envoy is \$25,000, and he sells an Envoy for \$40,000. He can sell half of all the leftover Envoys for \$30,000. He is trying to decide how many Envoys to order, so he builds a spreadsheet with models of orders of 200, 220, 240, 260, 280, and 300 Envoys. Jordan is able to calculate the number of Envoys he should order for his dealership by using a Monte Carlo simulation that runs on Microsoft Office Excel 2007.

To take advantage of publicly available data, we started with a Monte Carlo spreadsheet from Microsoft's Web site. (Adapted from Winston, W.L. (2004): *Microsoft*® *Excel*®: *Data Analysis and Business Modeling*. Washington: Microsoft Press, p. 462.) To make this initial spreadsheet more like one a real business might use, we added additional worksheets for each quantity of vehicles--200, 220, 240, 260, 280, and 300--that the dealer is considering purchasing.

We timed:

• the Microsoft Excel 2007 calculation from when Jordan presses F9 in Excel to start the recalculation until the Data Table indicator on the Status Bar goes away

Viewing a set of memorized reports in Intuit QuickBooks Pro 2006

Mark Owens is in charge of examining the books of a company, Rock Castle Construction, that his firm is interested in acquiring. He instructs his accountant to go through Rock Castle Construction's Intuit QuickBooks data file and prepare multiple memorized reports for him to review. When Mark receives the QuickBooks file from his accountant, he loads the file onto his system. He then opens the set of memorized reports to view Rock Castle's overall performance since its inception.

We timed:

• the appearance of the Intuit QuickBooks Pro 2006 reports from when Mark clicks Display until all the report windows are open

For more details on how we executed and measured these scenarios, our specific test functions, and the files the scenarios use, see Appendix B.

Test results and analysis

In this section we examine the results of each of our tests. Figure 2 shows the times, in seconds, that each test system needed to complete each scenario. The times we show for each platform for each scenario are from the median run of the five test runs of that scenario on that platform.

In the following sub-sections we explore these results in more detail. To make comparisons easier, we always show results normalized to those of the slowest system in the group, the Intel Pentium 4 processor 2.8GHz based PC with the Intel D865GBF motherboard. To compute those normalized results, we divided each system's time by the time it took the slowest system. The result for the Intel Pentium 4 processor 2.8GHz based PC with the Intel D865GBF motherboard is thus always 1.00, because it's the comparison basis. Results higher than 1.00 indicate how much faster a system is than that system. Because of the normalization, higher result numbers are better. For example, a result of 1.80 would mean the system in question was 80 percent faster than the Intel Pentium 4 processor 2.8GHz based PC.

Recalculating business revenue using Microsoft Office Excel 2007

As Figures 3 and 4 show, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 was 2.71 times faster than the Intel Pentium D processor 930 based PC on this test. Additionally, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 was 4.68 times faster than the PC with the Intel Pentium 4 processor 2.8GHz and the Intel D865GBF motherboard.



As Figure 4 shows, these differences represent significant improvements in the time it takes to perform each task. Compared to the Intel Pentium D processor 930 based PC, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 decreased the elapsed time from 77.34 to 28.55 seconds. Compared to the PC with the Intel Pentium 4 processor 2.8GHz on the Intel D865GBF motherboard, the Intel vPro technology based PC with the

Intel Core 2 Duo processor E6700 decreased the elapsed time from 133.58 to 28.55 seconds--a savings of over a hundred seconds.

Running a Monte Carlo simulation in Microsoft Office Excel 2007

Figures 5 and 6 illustrate the results of this test. The Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 was 3.12 times faster than the Intel Pentium D processor 930 based PC. Additionally, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 was 3.22 times faster than the PC with the



Intel Pentium 4 processor 2.8GHz on the Intel D865GBF motherboard.

As Figure 6 shows, these differences represent significant improvements in the time it takes to perform each task. Compared to the Intel Pentium D processor 930 based PC, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 decreased the elapsed time from 14.46 to 4.63 seconds. Compared to the PC with the Intel Pentium 4 processor 2.8GHz on the Intel D865GBF motherboard. the Intel vPro technology based PC

with the Intel Core 2 Duo processor E6700 decreased the elapsed time from 14.92 to 4.63 seconds.

Viewing data in Intuit QuickBooks Pro 2006

As Figures 7 and 8 show, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 was 1.91 times faster than the Intel Pentium D processor 930 based PC on this test. Additionally, Intel vPro technology



based PC with the Intel Core 2 Duo processor E6700 was 2.47 times faster than the PC with the Intel Pentium 4 processor 2.8GHz on the Intel D865GBF motherboard.

Figure 8 shows that these differences represent significant improvements in the time a user would need to perform each task. Compared to the Intel Pentium D processor 930 based PC, the Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 decreased the elapsed time from 7.94 to 4.15 seconds. Compared to the PC with the Intel Pentium 4 processor

630, Intel vPro technology based PC with the Intel Core 2 Duo processor E6700 decreased the elapsed time from 10.11 to 4.15 seconds on the task.

Test methodology

Setting up the test systems

To get the most accurate and repeatable results possible, start with a clean hard disk and set up all the test systems using the following procedures.

Installing Microsoft Windows Vista Ultimate

Use the following process to install a clean version of Windows Vista Ultimate on each system under test:

- 1. Install Windows Vista Ultimate Build 6000.
 - a. Boot to a Windows Vista Ultimate Build 6000 DVD.
 - b. When prompted, press any key to boot from the DVD.
 - c. At the language and preference screen, accept the default options, and click Next.
 - d. Click Install now.
 - e. Do not enter a Product key. Uncheck Automatically activate Windows when I'm online, and click Next.
 - f. At the Do you want to enter your product key now screen, click No.
 - g. Select Windows Vista Ultimate, and check I have selected the edition of Windows that I purchased.
 - h. Click Next.
 - i. Check I accept the license terms.
 - j. Click Next.
 - k. At the Which type of installation do you want screen, select Custom (advanced).
 - I. Click Drive options (advanced).
 - m. Select the destination Disk for the operating system.
 - n. Click Format.
 - o. Click OK at the all data stored will be permanently deleted dialog.
 - p. Once the system finishes formatting the disk, click Next.
 - q. Fill in the Username and Password fields, and click Next.
 - r. Fill in the computer name field, and click Next.
 - s. When the system presents the option to enable Automatic Updates, click Ask me later.
 - t. Select the correct time zone, date, and time, and click Next.
 - u. At the Select your computer's current location screen, click Public location.
 - v. Click Start at the Thank you screen.
 - w. When the Windows Vista Ultimate installation completes, close the Welcome Center Dialog.
 - x. At the Set network location screen, click Public location.
 - y. Click Close.
- 2. Set the test resolution.
 - a. Right-click on the desktop.
 - b. Select Personalize.
 - c. Click Display Settings.
 - d. If the monitor resolution is not already 1280 by 1024, adjust it to that setting.
 - e. Click OK.
- 3. Verify that Windows Automatic Updates are off.
 - a. Click Start.
 - b. Select Control Panel.
 - c. Click Security.
 - d. Under Security Center, select Turn automatic updating off.
 - e. Select the Never check for updates radio button.
 - f. Click OK.
- 4. Turn off System Restore. Doing so prevents such events from occurring during testing and affecting results.
 - a. Click Start.
 - b. Right-click Computer.
 - c. Select Properties.
 - d. Select System protection on the left.
 - e. Click Continue.

- f. Uncheck each box under Automatic restore points.
- g. Select Turn System Restore Off at the System Protection pop-up window.
- h. Click OK.
- 5. Add the system to the test domain.
 - a. Click Start.
 - b. Right-click Computer
 - c. Select Properties.
 - d. Select Change settings.
 - e. Click Continue.
 - f. Click Change.
 - g. Select the Domain radio button.
 - h. Type the test domain name.
 - i. Click OK.
 - j. Type the administrator credentials in the User name and Password fields.
 - k. Click OK.
 - I. Click OK at the Computer Name/Domain Changes dialog box.
 - m. Click OK again.
 - n. Close the System Properties window.
 - o. Close all other open windows before clicking Restart Now.
 - p. Log in.
 - q. Uncheck the Run at startup box on the Welcome Center before closing it.
- 6. Add the user to the Administrators group.
 - a. Click Start.
 - b. Right-click Computer.
 - c. Select Manage.
 - d. Click Continue.
 - e. Select Local Users and Groups on the left.
 - f. Double-click Groups in the center.
 - g. Select Administrators.
 - h. Click Add..., and type the domain test user account.
 - i. Click OK.
 - j. Type the administrator credentials in the User name and Password fields.
 - k. Click Apply.
 - I. Click OK.
 - m. Close all windows.
 - n. Click Start.
 - o. Click the arrow \rightarrow .
 - p. Select Log Off.
 - q. Press Ctrl + Alt + Delete at the prompt.
 - r. Click Switch User, and select Other User.
 - s. Type the test user's credential in the User name and Password fields.
 - t. Press Enter.
- 7. Turn all Power Management settings to Performance.
 - a. Click Start.
 - b. Select Control Panel.
 - c. Select Appearance and Personalization.
 - d. Under Personalization, click Change screen saver.
 - e. Select (None) from the Screen saver drop-down menu.
 - f. Click the Change power settings link.
 - g. Click the High performance radio button.
 - h. Select Never for the Turn off the display and Put the computer to sleep drop-down menus.
 - i. Click Change advanced power settings.
 - j. Click Hard disk \rightarrow Turn off hard disk after \rightarrow Setting (Minutes), then type Never.
 - k. Scroll down, and click Sleep→Sleep after→Setting (Minutes), and type Never.
 - I. Click Sleep→Allow Hybrid Sleep→Setting.

- m. Select Off.
- n. Scroll down, and click Display→Turn off display after→Setting, then type Never.
- o. Click OK.
- p. Click Save changes.
- q. Close the Power Options window.
- r. Click OK on the Screen Saver Settings.

Installing Adobe Flash Player 9.0

Use the following process to install a clean version of Adobe Flash Player 9:

1. Install Adobe Flash Player 9 from

http://www.adobe.com/shockwave/download/download.cgi?P1_Prod_Version=ShockwaveFlash&promoid =BIOW.

- a. Uncheck the box next to YAHOO! toolbar, and click Install Now.
- b. Click Continue at the User Account Control dialog.
- c. Click Install at the Security Warning dialog.
- d. Flash Player is successfully installed when the flash installation completion movie plays.

Installing Intuit QuickBooks Pro 2006

Use the following process to install a clean version of Intuit QuickBooks Pro 2006. This installation includes an automatic installation of the Microsoft .NET 1.1 Runtime.

Note: We occasionally received the following message near the end of the Intuit QuickBooks install: "Error 1904.Module C:\QB.ocx failed to register". We clicked Ignore to bypass this error.

- 1. Insert the Intuit QuickBooks Pro 2006 installation CD.
 - a. Click Run setup.exe.
 - b. Click Allow at the User Account Control screen.
 - c. Click Run program at the Program Compatibility Assistant screen.
 - d. Click Install at the welcome screen.
 - e. Click Next at the .NET 1.1 Runtime installation screen.
 - f. Click Next at the Welcome to QuickBooks Installation Wizard screen.
 - g. Select Accept, and click Next at the License Agreement screen.
 - h. Enter the Intuit QuickBooks License Number and Product Number, and click Next.
 - i. Accept the default installation path, and click Next.
 - j. Click Install at the Ready to install QuickBooks screen.
 - k. Click Finish at the installation complete screen.
 - I. Click OK at the QuickBooks has completed verifying configuration dialog.
- 2. After installation of Intuit QuickBooks Pro 2006 completes, configure the application for testing by following these steps once:
 - a. Launch the application by double-clicking the QuickBooks Pro 2006 desktop shortcut.
 - b. Click File \rightarrow Open Company.
 - c. Select sample_product based_business.qbw, and click Open.
 - d. Click OK at the QuickBooks Information dialog.
- 3. At the QuickBooks Learning Center screen, uncheck Show this window at startup, and close the Welcome screen.
- 4. Turn off automatic updates by following these steps once:
 - a. Click Help \rightarrow Update QuickBooks \rightarrow Options.
 - b. Select No to Automatic Update.
 - c. Click Save.
 - d. Close the Update dialog.
- 5. Close all open windows.
- 6. Close QuickBooks.
- 7. Launch Intuit QuickBooks Pro 2006.
- 8. Verify that a single window with the title No Company Open appears.
- 9. Close QuickBooks.

Installing Microsoft Office Enterprise 2007

Use the following process to install a clean version of Microsoft Office 2007 Enterprise on both the Windows Vista and Windows XP operating system images for each system:

- 1. Insert the Microsoft Office Enterprise 2007 DVD.
- 2. Select Run SETUP.EXE.
- 3. Click Continue at the User Account Control dialog.
- 4. Click Install Now.
- 5. Click Close at the Microsoft Office Enterprise 2007 has been successfully installed screen.

Appendix B – Instructions for running the application scenarios

We evaluated the performance of each of the test systems on each of the application scenarios (see the Application scenarios section for more information on them) by hand-timing the tasks in those scenarios.

We collected results for five runs of each scenario in each system configuration. We refer in this paper only to the median results of those runs on each system configuration. Lower times to complete a given function indicate better performance. We round those times to hundredths of seconds in this report.

In the following instructions, we assume you have already completed all of the setup work in the Test Methodology section.

Recalculating business revenue using Microsoft Office Excel 2007
